



Our Scientists and Engineers in Magnetic Miles LLC Labs Are Developing Safe and Renewable Energy That Can Conceivably Eliminate Coal, Oil, Natural Gas, Fossil Fuel, Open Pit Mining and Fracking

There are numerous damaging environmental impacts of coal that occur through its mining, preparation, combustion, waste storage, and transport.

- Greenhouse gas emissions caused by surface mining According to a 2010 study, mountaintop removal mining releases large amounts of carbon through clearcutting and burning of trees and through releases of carbon in soil brought to the surface by mining operations.
- Loss or degradation of ground water.
- Radical disturbance of 8.4 million acres of farmland, rangeland, and forests, most of which has not been reclaimed.

The Future of Fossil Fuels During the Transition to Alternative Energy

Fossil fuels will still provide 60% of energy in 2040, compared to 85% today, but the pattern of use will change, away from coal and towards gas, and increasingly concentrated in industry.

The impact differs across the different fossil fuels: Coal must decline sharply and immediately, by around two thirds to 2040. Coal use would increasingly be concentrated in steelmaking and industry. In power generation, of which coal accounts for 40% today, coal would therefore need to be phased out even more rapidly.

Oil consumption must peak sometime in the 2020s, and then fall by one-third to 2040. This will be accomplished mostly by finding alternative fuels within transportation, e.g. by large-scale electrification of the vehicle fleet. Natural gas use may rise slightly during the coming 25 years, before falling again to end up at roughly the same level as today in 2040. Gas will still be used across the energy system where alternatives are difficult to scale, e.g. some power generation, industry and heating.


LENR TECHNOLOGIES

Magnetic Miles LLC has, over the course of the past fifteen years, developed a technology that is applicable to the LENR industry. It is unique because it demonstrates the possibility of generating heat and electrical energy via the LENR mechanisms that is far greater than the energy inputs required to drive the process in a controllable manner.

The heat energy generated by LENR was speculated to be on the order of 10,000 times that supplied to the reaction for extremely short periods of time, the gain in electrical energy is 1.18 x 104. It does this in a controlled manner, where the output parameters of the LENR are controlled by the operating characteristics of the MMIC device. The next step is to explore and expand the basic controlled LENR technology to the point where it can be transferred to the utility level power generation and to expand the nuclear waste remediation technologies to the point that the appropriate industrial entities that have the capability, in terms of engineering and manufacturing know-how, can take it and develop the technology for their own applications.

When completed, the new technology will make existing fossil fuel and nuclear power generation technologies obsolete, and will provide a proven, fast and cost effective method for cleaning up existing nuclear contamination.

There is a sizable and growing community of industrial and governmental organizations that are committing ever-increasing resources to the goal of proving the viability of those same scientific findings.




Magnetic Miles LLC Power Source
